### OPERATING RESTRICTIONS

- The Permit Registration must be with the UTV/Snowmobile whenever said in operation.
- A person shall not drive or operate an UTV:
  - a. Unless they are 18 years of age, have a valid driver's license-are registered with the Iowa Department of Natural Resources (IDNR) with properly displayed registration decal and have a valid proof of insurance on their UTV OR
- Passengers under the age of 18 shall have an approved helmet.
- Operators shall abide by all traffic laws and posted traffic signs.
- Obey the posted speed limit or 35 mph, whichever is less.
- May be operated on all City streets with the following exceptions:
  - a. A street which is a primary road extension (this prohibition shall include Highway 3 and Highway 150) through the City, but shall be allowed to directly cross a City street that is a primary road extension through the City.
- See City Ordinance Article IX for further restrictions.
