### **SPECIAL NOTES**

The Oelwein Residential Tax Abatement runs from January of 2023 to January of 2027. The tax abatement program lasts for five years, at which point, Council will re-evaluate the program.

The tax abatement will stay with the property regardless of the owner.

While the State of Iowa no Ionger has a property tax classification for the multifamily category, the city classifies multifamily as more than one dwelling unit per property. A duplex all the way up to a full-size apartment building or town home can qualify.
